SELECTMEN'S REPORT

To the Citizens of Hinsdale:

As the year of 1964 draws to a close, we wish to report the following projects that have been completed:

Michaels Road has been rebuilt and surfaced in its entirety.

The Board also wishes to report, with a great deal of satisfaction, that the drainage problem on Maple Street has been rectified with the installation of underground pipe extending from the Grange Hall to the Town property at the Peat Bog. In the process of doing this job, we started to straighten the existing corner where Plunkett Street intersects Maple Street. This work should be completed in 1965.

The Board is proposing that a new Power Grader be purchased for the Highway Department. The Town of Hinsdale is one of the few remaining towns in Berkshire County that does not own one. This piece of equipment would be used on a year-round basis. In the summer, for leveling and grading on new construction as well as for standard scraping of ditches and surfaces on Chapter S1 roads.

It is thought that in the future it might not be necessary to either buy or erect snow fence which could amount to a substantial saving to the Town because if the Power Grader were purchased, it can be used to great advantage, particularly in the winter months, when it can be used to great advantage in both widening and winging back the roads, especially where there is a lot of heavy drifting.

A considerable amount of money used in hiring bulldozers and large trucks to open and push back roads will not be necessary with a Grader. This also would take the strain off our other pieces of equipment and consequently would result in a savings in maintenance costs.

It was necessary to call only one Special Town Meeting during the year. This meeting was held on July 29, 1964, and the following business was transacted:

Article II. It was voted to transfer the sum of \$4,768.46 which is to be received from the Commonwealth of Massachusetts under the Provisions of Chapter 822, or the Acts of 1963, to rebuild and install a storm drain on a section of Maple Street and to straighten the existing corner at Plunkett and Maple Streets.

Article III. It was voted to close out the postwar rehabilitation fund of \$2,966,88, and to transfer this amount to the stabilization fund.

Article IV. The sum of \$1,500 was transferred from Free Cash to be used for repairing and painting the Hinsdale Library.

Article V. It was voted to enact a By-Law pertaining to unregistered and dilapidated motor vehicles.

The Board of Selectmen are asking that the By-Law concerning the number of voters required to make a quorum at Town Meeting be changed to (12) twelve voters rather than the precentage which it is now (this varies from approximately 27 to 30). It has been proven in the past two years that it is almost impossible to get this number of voters to special meetings where they are asked to vote on routine articles only, although such articles are necessary to the function of Town business.

The Board wishes, at this time, to thank the Ashmere Reservoir Association for their generous gift in conveying Plunkett Lake Reservoir to the Town. We think this body of water is a very valuable asset to Hinsdale, and with proper planning it can be used to the Town's greatest advantage as a recreational area. Our Conservation Commission has this project under their supervision and we feel they are doing an excellent job toward future planning for this area.

Through efficient handling of men and equipment, our Road Superintendent has again kept the winter road maintenance spending near the \$12,000.00 mark and we give him a pat on the back for this accomplishment.

ORDER OF BUSINESS

The Commonwealth of Massachusetts

To one of the Constables of the Town of Hinsdale:

GREETING:

In the name of the Commonwealth of Massachusetts you are hereby required and directed to notify and warn the inhabitants of said Town of Hinsdale qualified by law to vote in the election and town affairs, to meet in the auditorium of Kittredge School in Hinsdale on Saturday, February 13, 1965 at 10:00 A. M. to choose and elect by official ballot the following officers:

Moderator for one year, one Selectman for three years, one Assessor for three years, one member of the School Committee for three years, Auditor for one year, Tree Warden for one year, three members of the Finance Board for three years, one Constable for three years, one Representative to Central Berkshire Regional School District.

The polls will be open at 10:00 o'clock A. M. and will remain open continuously until 6:00 P. M. of said day when they may be closed.

You are further required to notify and warn the aforesaid voters of said Town of Hinsdale to meet in the Kittredge School Auditorium on Monday, February 8, 1965 at 7:00 P. M. then and there to act on the following articles:

- Art. 1—To see if the Town will vote to authorize the Selectmen to appoint all non-elective minor officers necessary or required to be chosen by the Town.
- Art. 2—To act upon the reports of the Selectmen, the School Committee, and other elected or appointed officers of the Town.
- Art. 3—To see if the Town will vote to accept the list of jurors presented by the Selectmen.

Art. 4—To see if the Town will vote to give the Tax Collector the same powers Town Treasurers have by law when appointed Collector of Taxes.

Art. 5—To see if the Town will vote to authorize the Town Treasurer, with the approval of the Selectmen, to borrow money from time to time in anticipation of revenue or reimbursement of the financial year beginning January 1, 1965 and to issue a note or notes therefor payable within one year, and to renew any note or notes as may be given for a period of less than one year in accordance with Section 17, Chapter 44, General Laws.

- Art. 6—To see if the Town will vote to constitute the Board of Selectmen the Board of Public Welfare for the year 1965 and to authorize an annual salary of \$50 for each member for attendance at meetings and \$50 additional for the District Representative for attendance at District meetings.
- Art. 7---To see if the Town will vote to have the cash in the Treasury transferred to help defray the expenses of the ensuing year.
- Art. S—To see if the Town will vote to appropriate from the Overlay Reserve surplus fund the sum of \$3500.00 for a Reserve Fund.
- Art. 9—To see if the Town will vote to transfer from the State Aid for Libraries Account the sum of \$500.00, this sum and the amount of Dog Tax money refunded by the County to be given to the Hinsdale Free Public Library.
- Art. 10—To see if the Town will vote to raise and appropriate \$200.00 for work on the Plunkett Reservoir Road.
- Art. 11—To see if the Town will vote to appropriate \$12,950.00 for Chapter 81 Highway Maintenance; \$2,775.00 to be raised by taxation, and the remainder by borrowing in anticipation of reimbursement or by transferring from unappropriated available funds in the treasury.
- Art. 12—To see if the Town will vote to appropriate \$14,000 for Chapter 90 Construction; \$3,500.00 to be raised by taxation and the remainder by borrowing in anticipation of reimbursement. The money to be used as follows: \$12,000.00 to continue work on current Chapter 90 projects, \$2,000.00 to be added to the fund for rebuilding the bridge on Old Dalton Road, over the Housatonic River at the junction with Route 8.
- Art. 13—To see if the Town will vote to appropriate \$6,000.00 for Chapter 90 Highway Maintenance; \$2,000.00 to be raised by taxation, and the remainder by borrowing in anticipation of reimbursement or by transferring from unappropriated available funds in the treasury.
- Art. 14—To see if the Town will vote to transfer \$3,611.65 from the Road Machinery Fund for Road Machinery Maintenance.
- Art. 15—To see if the Town will vote to raise and appropriate the sum of \$500.00 for the 1965 Decennial Census.

- Art. 16—To see if the Town will vote to raise and appropriate the sum of \$25,000.00 to purchase a new Power Grader and accessories. \$10,000. of this amount to be transferred from free cash, and to authorize the Treasurer to issue five notes for the remainder, these notes to be \$3,000.00 each, payable each year for five years.
- Art. 17-To see if the Town will vote to raise and appropriate the sum of \$250.00 for the maintenance and care of Plunkett Lake.

- Art. 18-To see if the Town will vote to transfer the street light on pole 46/40, on New Windsor Road, to pole No. 46b/30, on Windsor Road.
- Art. 19-To see if the Town will vote to authorize a revaluation and to raise and appropriate \$6,500.00 to cover expenses.
- Art. 20-To see if the Town will vote to accept the provisions of Chapter 41, Section 97A, concerning the appointment of police officers.
- Art. 21-To see if the Town will vote to raise and appropriate \$500.00 for legal counsel.
- Art. 22-To see if the Town will vote to change the number of voters for a quorum at Town Meetings from 4% to the number 12.
- Art. 23—To see if the Town will vote to raise and appropriate the sum of \$275.00 to purchase a steel E Z tilting flag pole. This amount added to the \$100.00, carried from 1964, will pay for the pole and its erection.
- Art. 24—To see if the Town will plow, sand and maintain Bridge Street. In particular, the steep section of road bordered on both sides by an iron fence leading down to the only house that can be approached on Bridge Street presently owned by Richard Zoph.
- Art. 25-To see if the Town will vote to raise and appropriate the sum of \$150.00 for maintenance of Town Garage.
- Art. 26—To see if the Town will vote to fix the salaries of the Town Officers in accordance with Section 108, Chapter 41 of the General Laws, as follows:

REPORT OF THE FINANCE COMMITTEE

All items for the 1965 budget have been reviewed by the Finance Committee, the total of which is \$385,001.86. When the total of the known available monies is subtracted from the budget total, we have an increase of approximately \$9,936 over last year (1964) to be raised, this could mean a tax rate increase of \$4.50, based on present valuations.

The major increases in the new budget are in the school operating monies, we do have some new accounts this year which contribute to the increase. (see budget comments which follow)

During the course of the year, transfers from the Reserve Account were as follows:

Comments on items in the budget

In an attempt to explain what appears to be a big jump in the Kittredge School operating money, we must compare notes on the actual budget of 1964 and actual budget for 1965 as related to use of Public Law No. 874 money.

The actual school budget in 1964 was \$113,967 of which \$6,834 was used from the returns to the Town under Public Law 874. The actual amount of money spent by the school department in 1964 was \$109,687. Since the Town appropriation for 1964 was \$107,133, this means that only \$2,553 was spent of the Public Law 874 money and the remainder of \$4,280 was carried over and used in the 1965 budget. Since this money source is reducing each year the School Committee saw fit to use only \$4,000 against the 1965 budget. The actual school budget for 1965 is estimated at \$116,918 and using the Public Law 874 money of \$4,000, to reduce it leaves a figure of \$112,918 to be raised for 1965. The actual difference in the school budget between 1965 and 1964 shows a \$2,951 increase, but because of the difference in available Public Law 874 money there is an increase of \$5,785 in money to be raised.

School Lunch Subsidy—This appropriation has been reduced this year as a result of an agreement between the Selectmen and the School Committee, wherein the program will now be controlled completely by the School Committee and all payments for the operation of the program will be supervised and made from the lunch program fund, which is a revolving fund. The Town will subsidize the fund this year by \$1,200. This amount of subsidy will be determined each year. The amount of subsidy will be paid as a lump sum to the Lunch Program Revolving Fund.

Regional School—While Hinsdale's percentage responsibility of the Regional School operating budget dropped from 15.87% in 1964, to 15.53% in 1965, we have an overall increase because of the total budget increase of about 8%. Our increase was about 5%. Unfortunately our decrease in the capital costs does not balance the increase in the operating costs.

Our main charity accounts were reduced in total this year by some \$5,000, however the administration costs were increased by \$775.94, due in part to increased cost of housing.

The Veterans' Aid account was very active again this past year and has been increased for 1965 by \$1,000.

Plunkett Lake Maintenance—This is a new account this year and will continue for the purpose of general maintenance of the dam site area and water level.

Vacation Account—This money has been increased this year to allow for a two-week paid vacation for those regular workers in the Highway Department with full time.

New Flag Pole—There was no money spent in 1964 from this account because it was found that the desired installation could not be covered by available money. An additional amount of \$275. is being requested this year to be added to last year's money, the total of which is expected to cover the purchase and installation of a new flag pole on the library lawn.

Decennial Census—This request appears every ten years for a complete census of the Town.

Town Counsel—This account is new this year and will continue at the request of the Selectmen.

Re-Assessment of Town—This request has been made by the Assessors of the Town for the purpose of hiring in a qualified assessing firm to up-date all real estate assessments in line with the 100% valuation trend. The \$6,500. requested could mean an estimated \$2.80 on the tax rate with present values.

Power Grader—The Selectmen have requested this item, which they feel will be of good value to the Town in carrying out the highway maintenance both Summer and Winter. The unit is to be equipped with both grader blade and snow plow. The Finance Committee feels that the \$25,000 requested can be handled by taking \$10,000 from available surplus and spread the remainder over five years with notes at \$3,000 each. This would not reflect in the tax rate this year but would add an estimated \$1.25 each of 5 years to the tax rate, starting in 1966. (based on present valuation).

Baseball—Don Cornwall and Bruce Drosehn coached our two entries in the Dalton-Hinsdale Pee Wee League. Don's interest in this program has covered many years. The Committee thanks both for their services.

Football—Charles DeAngelus continued the football program. The Recreation Committee assumed the paying of insurance and the cleaning of uniforms. We also purchased thirty new jerseys.

Basketball—The winter program for High School boys was started in November with Bruce Drosehn in charge. Girls' basketball was revived for High School girls. Patricia Porter and Marilyn Galeucia are in charge. Jerry Vranas is supervisor of the program.

REPORT OF FIRE CHIEF AND FOREST WARDEN

To the Board of Selectmen:

Gentlemen:

I hereby submit my report as Chief of the Fire Department in the Town of Hinsdale for the year ending December 31, 1964.

The Department answered 32 calls as follows: grass 7, houses 9, dump 8, mutual aid 3, car fires 2, planks on bridge 1, diesel engine 1, false alarms 1.

We consider the fire in the engine compartment of the diesel the biggest challenge to our Department this year. This type of fire was never fought by the men before; it being a class B & C fire, it was fought with dry chemical.

A total of 25 applications for installations and permits for all type of oilburning equipment and oil storage were issued.

Outdoor practices were held all summer. Fifteen men completed a Basic Fire Fighting Course held at Peck's Road drill ground.

The amount of \$408.45 was spent for repairs on the Ford Pump this year after a small stone had become caught on the inside of the packing gland and scored the shaft. We experienced trouble with the siren but this was fixed at a cost of \$151.99. This is believed to be the first time in 37 years that the siren was out of working order.

As of this date our fire fighting equipment is in good condition.

I wish to thank the townspeople for their cooperation and also the Firemen's Auxiliary for their help. I would also like to mention how hard the Muster Team worked this past year and they are now the holders of the New England Muster Champs Title and Trophy.

All outdoor fires require a permit except those in a closed container. No permits are issued on Sundays until after 12:00. For permits the following numbers can be called:

REPORT OF THE CUSTODIAN OF WAR MEMORIAL

To the Board of Selectmen:

The War Memorial on the Library lawn is now in good condition, and barring unforeseen incidents no repairs will be needed in 1965. Minor repairs, such as caulking around plaques, were made the past summer. John Goddard volunteered the labor and material for this work. No moneys appropriated for monument repairs, \$50 in 1964 and \$14 carried over from 1963 were used.

Many out-of-town people stop during the year to examine the memorial andto praise the excellent condition of this monument to those Hinsdale men and women who served in all of America's wars. William N. Bissell of Albany, N. Y. visited the memorial in September in the interests of the *John Bissell* 1628 Association which has offered to give a small plaque in memory of the postrunner, Israel Bissell, a descendant of John Bissell, who is buried in Maple Street Cemetery.

The flag pole at the monument was painted a coat of white paint in time for Memorial Day by volunteers John Goddard, Clayton P. Fancher, Jr., Ralph Cormier, the Fire Department and others. Ladders were loaned by the Fire Department. Labor was free. The rope and hooks on the pole were replaced by volunteer labor. A new flag pole, for which \$100 was appropriated at the February 1964 Town Meeting, was not bought as money was insufficient. The custodian has made inquiries of several companies as to cost of new pole and hopes to have a new one, permanent, erected before May 30, 1965.

REPORT OF EASTERN BERKSHIRE WELFARE DISTRICT

Report of Director to Town of Hinsdale:

The Eastern Berkshire Welfare District office completed the thirteenth year of administration of Public Welfare for Becket, Hinsdale, Peru, Washington and Chester on December 31, 1964.

The office was originally established in the Hinsdale Town Hall on August 1, 1951, but moved to quarters in the Frissell Block in September 1951. With the addition of two new workers in 1961, increasing the staff to five; the accumulation of records which must be kept, and the need for privacy which is the right of any client who applies for aid, it has been necessary to look for larger office space. Following several months' consideration of the problem by the Prudential Committee, bids were sought, resulting in the new building now being constructed on South Street. The new building will be ready for occupancy March 1.

The general public, it would appear, has little conception of the organization and functions of the Public Assistance Program at both the state and local levels.

The four programs administered by the Massachusetts Department of Public Welfare are Old Age Assistance, Aid to Families with Dependent Children, Disability Assistance and Medical Assistance to the Aged. The intent of the Social Security Act is the alleviation of need. It provides for the minimum standard of living for all people that they may be assured of a standard of living that is decent and in keeping with the ideals upon which this country was founded and continues to operate.

Old Age Assistance is designed for persons 65 or over who have insufficient resources with which to meet their needs. An applicant must be in need and may have less than \$500 in tangible assets. Applications may be made at the District Office and are taken by either the Director or Social Worker.

The Aid to Dependent Children program amended to Aid to Families with Dependent Children under the Social Security amendments of 1962, is a program designed primarily to aid those children deprived of a working parent or bread winner. Under this program, children and their mothers are eligible for public assistance if the father is absent from the home by death, desertion or is disabled.

Disability Assistance was instituted in 1951. This type of assistance is given to an individual between the ages of 18 and 65 who is permanently or totally disabled and therefore unable to be gainfully employed. This disability may be of a mental or a physical nature and the extent of such disability is determined by the Medical Review Team of the Massachusetts Department of Public Welfare.

Medical Assistance to the Aged, the newest form of assistance, established October, 1960 made possible under the provisions of the Kerr-Mills Bill passed by Congress in that year. This bill provides medical care for the aged citizen over 65 and requires a means test. This program is not based on budgetary needs.

The fifth category of assistance known as General Assistance is administered by the Director under supervision of the Board members. It should be pointed out that General Assistance cases are constantly screened in an effort to transfer any cases to another type of assistance because of a physical disability. Those temporarily unemployed are generally awaiting unemployment benefits. All possible Social Security benefits are explored. In the area of supplementary aid to the low income group, there are those with large families who do not earn enough to support the family in accordance with the State Standards of Assistance. Budgetary needs are computed on the basis of the number in the family, age and living arrangements. Wages earned are used as a resource. The difference between the budgeted needs and the resource is a deficit. There are times when the deficit needs to be met in order for such a family to maintain itself. At times it may be only medical care which needs to be supplemented.

All able-bodied men, unemployed, are required to work in one of the Town maintenance departments for all aid given.

On January 1, 1964, there were 6 cases receiving Aid to Families with Dependent Children, with a total of 5 adults and 10 children being aided. In February, 2 cases were closed; in April, another case was closed and one opened. In July, one more case was closed and in September, a new case was added. This case closed at the end of November and at present 3 cases continue to receive aid. During the year, 8 cases received assistance. During the year 8 cases received welfare aid representing 8 adults and 14 children. Costs were high due to extensive hospitalization for two children and one parent.

This program is carried on in conformance with the new concepts contained in the Public Welfare Amendments of 1962 of the Social Security Act (Public Law 87543). In order to insure 75% Federal matching, the District office is committed to the purposes of the program. Revisits are made every three months and as often as necessary beyond this. The total resources from deserting or divorced fathers by court order has been \$612.00.

Disability Assistance expenditures have been reduced this year. Four cases at the present time receive aid and two of the four cases receive Social Security benefits.

The Old Age Assistance cases remain fairly static. There is a shift between our Old Age Assistance and Medical Assistance to the Aged. Old Age cases needing nursing care are automatically transferred to Medical Assistance to the Aged in accordance with state policies. As of December 31, the average age of cases receiving Old Age Assistance was 81.

Most of the cases receiving Medical Assistance to the Aged are in local nursing homes. Three of the cases receive \$15.00 each a month for clothing and personal care. The rest receive Social Security benefits which take care of their clothing and personal care and partially pay for cost of nursing care.

At our own local level, we strive to fulfill the concepts and philosophy of the public assistance program as prescribed in the forward of our manual. The fundamental aim of this program in Massachusetts is through financial assistance and service to meet the basic needs of those people who are unable to meet them through their own efforts and resources.

I wish to express my appreciation of the interest and cooperation of the town officials in carrying out the public assistance principles. Combined teamwork insures a healthy sound program.,

REPORT OF ROAD SUPERINTENDENT

To the Selectmen of Hinsdale:

The following is an account of work done during 1964.

Chapter 81

All dirt roads were scraped at least three times. All roads were graveled where needed. Treated with stone and asphalt were Curtis Street for 1,000 feet and Maple Street for 1,500 feet. Commonwealth Avenue has been widened to 30 feet, this street has been a bottle neck, for years. Three miles of road in the Town were also widened with our front end loader.

Chapter 90 Maintenance

Treated with stone and asphalt:

New Windsor Road	2,500 feet
Frank Schnopp Road	1,800 feet
Pittsfield Road	1,700 feet
Peru Road	2,000 feet

Chapter 90 Construction

Michaels Road received 1,400 ft. of new construction this year. This work was done early in the spring, so this road could be blacktopped before the traffic got heavy. This work was completed in June. The road is now paved for one mile and is 20 feet wide.

We now went to Creamery Road, 1,200 feet of new construction was done there this year too. Thanks to our front end loader we were able to put 600 yards of gravel per day on the road. We also used it to do a great deal of excavation that we would have had to pay a shovel to do, which saved the Town money, and put money in the Earnings fund at the same time.

Bridges

Drosehn bridge was eliminated. Two years ago I took this matter up with State engineers, asking if Chapter 81 money could be used to purchase a boiler pipe to put in the stream. They gave their consent, but due to the fact that Peru owns half of the bridge, it was necessary to consult the Selectmen of Peru. They were very much in agreement with this project. Each Town paid half of the costs. A pipe seven-feet in diameter and 36-feet long was installed. We now have a road from the Drosehn home to the brook a distance of 600 feet that is 26 feet wide, where it was only 10 feet wide before. All the work was done with our loader and truck. Widening this road will save money on snow removal in the winter time.

We are using 1,600 tons of washed sand, and 60 tons of salt, on winter roads today, compared to 800 tons of sand, and 30 tons of salt before 1961. The owners of trucks get \$6.75 per hour today compared to \$5.50 in 1961. I still am doing the work for \$12,000.00 per year, compared to 17, 18, and \$19,000.00 in previous years.

More snow fence goes up every year, about 1,000 feet.

We are in need of a power grader. The old tractor drawn grader is a thing of the past. The one we now have is forty years old, yes, it was manufactured in the year of 1925. It simply won't go another year.

We still have twenty miles of dirt roads to take care of. All of these roads could be widened with a power grader.

One man can operate this machine, where it takes two with the scraper and loader. You don't need extra help to throw the large stones out of the road after scraping, the machine does this by itself.

This machine will save money on snow removal. I hope you will think of this at your business meeting.

Bond Issue

On Maple Street there was a deep ditch that overflowed for years, depositing leaves and sand on property owners. Permission was granted by the State engineers to use Bond Issue money for this job.

We dug a trench 1,200 feet long, built catch basins, and laid in a 22-inch pipe, all the way to the peat bog. The land was graded and seeded.

We are now ready to come down Maple Street with a new paved road, such as we have done on the east end of the Street.

Thanking the Board of Selectmen, who have always worked with me at all times. I would also like to thank the State engineers, the men and truck drivers for their loyalty and cooperation.

REPORT OF VETERANS' AGENT

Veterans' Aid, financial and administrative was granted to a total of twentysix veterans during the past year. A record for financial aid was set when $9,000\ 00$ was expended.

The bulk of this record expenditure went for everyday living expenses for qualified veterans' families.

As was outlined in Veterans' Agent report for the year 1963, advancing age of World War II veterans is beginning to take its toll, relative to Veterans' Aid appropriation.

With this thought in mind, a \$10,000.00 budget appropriation is being asked for 1965. Another factor contributing to the request for \$10,000.00 is a flat five per cent increase in all categories of aid, as outlined by the Commissioner of Veterans' Services for the Commonwealth of Massachusetts. This five per cent increase went into effect as of January 1, 1965.

Nursing Home rates have risen 65 cents a day per person during the past year.

Veterans' Services have one Nursing Home case at present and it is expected that this case will require aid for the full year upcoming. This particular patient has an income, so the full responsibility does not rest with Veterans' Services. However, a minimum of \$1,392.00 will be needed for just this one isolated case.

From this one example, it can be clearly seen that an appropriation of \$10,000. is a realistic figure for this Department.

In conclusion, I would like to point out that approximately 65% of the \$9,000.00 expenditure will be reimbursed to the Town by the Commonwealth. This abnormally high percentage is a result of special conditions prevailing in two cases that required aid of substantial amounts.

REPORT OF CONSERVATION COMMISSION

1964 was a year of concern and responsibility about water and the lack of water. Early in the season this Commission was delegated the care of Plunkett Lake. Richard Greb, Sr. was appointed by the committee to attend the various maintenance operations necessary to keep a desired water level, and keep the equipment in good repair.

Tests made during the summer by the Department of Fisheries and Game showed the pond to be out of balance relating to the health, size, and quantities of fish. Authority was granted this department to eliminate the existing fish in the lake, and restock at the proper time. This program was carried out during the months of October, November, and December. The Hinsdale Conservation Commission, with the hoped for supplementary financial assistance from other sources, would like to add several hundred trout to the restocked population of other fishes which now number in excess of four thousand.

There was some concern about the lack of public access to Ashmere Lake. Mr. Gaston Roberts kindly offered his ramp for public use on the south side of Route 143. This Commission hopes to be able to secure suitable facilities on the north side in 1965.

Further studies and talks were continued relating to anti-pollution measures. As yet, no economically feasible solution has been offered.

This Commission was opposed in principal to the use of the water from Ashmere by the City of Pittsfield. Before and during the public hearing our members urged the Pittsfield officials to seek elsewhere for permanent sources of supply, since the economy and recreation of our town, and fire protection and welfare of the residents surrounding Ashmere Lake depend upon a seasonal constant level of the lake.

The thoughts of our nation are being directed toward the preservation of our natural resources and heritage. Presidential and congressional action are giving support and fact to open space and wilderness areas. Let us, in Hinsdale, be aware of our abundant beauty and help to retain, maintain, and improve our part of this land.

REPORT OF AN AUDIT

To the Board of Selectmen

Mr. Garrett F. Collins, Chairman Hinsdale, Massachusetts

I submit herewith my report of an audit of the books and accounts of the town of Hinsdale for the period from August 23, 1962 to February 26, 1964, made in accordance with the provisions of Chapter 44, General Laws. This is in the form of a report made to me by Mr. William Schwartz, Assistant Chief of Bureau.

Sir:

In accordance with your instructions, I have made an audit of the books and accounts of the town of Hinsdale for the period from August 23, 1962, the date of the previous examination, to February 26, 1964, preparatory to a recommitment of the outstanding taxes and excise to the newly elected tax collector, and submit the following report thereon:

The records of financial transactions of the several departments collecting or disbursing money for the town or committing bills for collection were examined, checked, and verified.

The books and accounts of the town treasurer were examined and checked in detail. The recorded receipts were analyzed and compared with the records of the departments collecting money for the town and with other sources from which money was paid into the town treasury, while the payments were compared with the selectmen's warrants authorizing the disbursement of town funds. The cash book additions were verified, and the cash balance on February 26, 1964 was proved by reconciliation of the bank balance with a statement furnished by the depository, by examination of the savings bank book, and by actual count of the cash in the office.

The recorded receipts for temporary loans were checked, and the payments on account of maturing debt, temporary loans, and interest were compared with the amounts falling due and with the cancelled securities on file. The records of payroll deductions on account of Federal and State taxes and the county retirement system were examined. The deductions were listed, the payments to the proper agencies were verified, and the balances in the general treasury were proved.

The tax title and tax possession records were examined and checked. The amounts transferred from taxes were compared with the records of the tax collector, and the amounts received on account of redemptions and sales were checked with the treasurer's receipts. The tax titles and tax possessions on hand were listed and compared with the records at the Registry of Deeds.

The savings bank book representing the investment of the Stabilization Fund in the custody of the town treasurer was examined and listed, the income being proved.

The books and accounts of the tax collector were examined and checked in detail. The accounts outstanding at the time of the previous examination, as well as all subsequent commitment lists of taxes and excise, were audited and proved with the assessors' warrants issued for their collection. The collections, as recorded, were compared with the payments to the treasurer, the abatements were checked with the assessors' records of abatements granted, the transfers to the tax title account were proved, and the outstanding accounts were listed and proved.

Further verification of the outstanding accounts was obtained by mailing notices to a number of persons whose names appeared on the books as owing money to the town, and from the replies received it appears that the accounts, as listed, are correct.

Aggregates of the outstanding tax and excise levies were furnished to the board of assessors for the purpose of recommitment, and detailed lists were furnished to the newly elected tax collector for his information.

The financial records of the town clerk were examined and checked. The recorded receipts for selectmen's licenses, as well as for dog and sporting licenses, were checked, and the payments to the Division of Fisheries and Game and to the town treasurer were verified. The cash on hand February 26, 1964 was proved by actual count.

The appropriations were listed from the town clerk's record of town meetings, and the amounts voted were compared with the aggregate appropriations raised by the assessors in the determination of the tax rate for 1963.

The survey bonds on file for the several town officials required to furnish them for the faithful performance of their duties were examined and found to be in proper form.

The records of receipts of the sealer of weights and measures, as well as of the police, public welfare, veterans' services, school, and cemetery departments, and of all other departments collecting money for the town or committing bills for collection, were examined and checked with the treasurer's cash receipts. The outstanding accounts were listed and proved, and the cash on hand in the several departments was proved by actual count.

Ledger accounts were compiled, and a balance sheet, which is appended to this report, was prepared showing the financial condition of the town on February 26, 1964.

Appended to this report, in addition to the balance sheet, are tables showing a reconciliation of the treasurer's cash, summaries of the tax, excise, and departmental accounts, as well as a schedule showing the transactions and condition of the investment fund.

On behalf of my assistants and for myself, I wish to express appreciation for the cooperation extended by all town officials during the progress of the audit.
